

**MEMORANDUM OF UNDERSTANDING (MoU)**  
between

This Memorandum of Understanding (MoU) is made on this 12 day of Dec, 2025, between:

**A. 100 Transcripts LLP**

A Limited Liability Partnership incorporated under the LLP Act, 2008 having its registered office at 101, New Avantika's Orchid, Matrusri Nagar Hyderabad, Telangana-500 049.

Represented by Mr. Rahul Alampatti Designation: Director.  
(hereinafter referred to as "100 Transcripts", which term shall include its partners, successors, and permitted assigns).

AND

**B. Bhaskar Pharmacy College**

Located at Yenkapally Village, Moinabad Mandal, Ranga Reddy District, Telangana-500 075.

Represented by Dr. A-Srinivasa-ha Designation: principal  
(hereinafter referred to as "BPC", which term shall include its administrators, successors, and permitted assigns).

100 Transcripts LLP and Bhaskar Pharmacy College are hereinafter individually referred to as a "Party" and collectively as the "Parties."

**1. Purpose of the MoU**

The purpose of this MoU is to establish a formal collaboration between **100 Transcripts LLP** and **Bhaskar Pharmacy College** for providing documentation, transcript procurement, academic verifications and related student-support services for the students and alumni of BPC.

---

## **2. Scope of Collaboration:** Under this MoU,

100 Transcripts LLP shall:

1. A dedicated web portal link, communication channel for BPC (email/phone coordination) students.
2. Provide transcript procurement services, Pharmacy Council/IEE/ECE/WES/ TEC and other evaluation support, provisional/Bonafide/migration/TC/Study/SOP/LOR and other academic documentation services.
3. Assist BPC students and alumni in national/international higher education, immigration, credential evaluation, and employment documentation needs.
4. Offer end-to-end support including application filing, status tracking, dispatch updates, and attestation assistance.
5. Conduct awareness sessions and workshops on global education and credential evaluation guidance if required.

BPC shall:

1. Provide access to necessary academic records for service processing, under applicable rules and regulations.
2. Facilitate issuance of transcripts and documentation upon Alumni/Student consent.
3. Communicate this partnership to students/alumni for awareness (if mutually agreed).
4. Provide a dedicated web portal link, single point of contact for coordination with 100 Transcripts LLP.

---

## **3. Deliverables**

**100 Transcripts LLP will deliver:**

- Secure and timely handling of documentation.
- Standardized service workflows and digital tracking.
- Periodic status updates and coordination reports.
- Discounted or institution-specific service packages (if customized).
- Provides part-time employment opportunities to BPC students based on the tasks received.

**Bhaskar Pharmacy College will deliver:**

- Verification or attestation support (as per institutional policy).
- Prompt responses for document processing.
- Space/support for student awareness programs (if conducted).

---

**4. Validity**

This MoU shall remain valid for a period of **five (5) years** from the date of signing and may be renewed upon mutual consent.

---

**5. Financial Terms**

1. Students will directly pay 100 Transcripts LLP as per selected service packages unless otherwise mutually agreed.
2. No financial obligations arise for BPC under this MoU unless specified in a separate written agreement.
3. Any special pricing or institutional discounts will be documented in an annexure.

---

**6. Confidentiality**

Both parties agree to maintain strict confidentiality of all shared academic records, student data, and institutional information, in compliance with applicable laws and data-protection principles.

---

**7. Liability**

100 Transcripts LLP shall be liable only for services handled directly by them and not for delays caused by external agencies such as colleges/universities/courier services/evaluation bodies, etc.

BPC shall not be liable for any third-party delays or issues arising outside its control.

---

**8. Intellectual Property**

Logos, names, and brand assets of either party may be used only with prior written consent and only for purposes related to this MoU.

---

## 9. Termination

Either party may terminate this MoU with **30 days' written notice**.

All ongoing student applications will continue to be serviced until completion.

---

## 10. Dispute Resolution

In case of any dispute, the parties shall attempt resolution through mutual discussion. If unresolved, dispute shall be subject to the jurisdiction of the **courts of Hyderabad, Telangana, India**.

## 11. Amendments

Any modification to this MoU must be made in writing and signed by both parties.
