- 16. This agreement shall take effect from the date of the signature below and will be valid for a period of Five years. Thereafter, it can be renewed for subsequent Five year periods with mutual consent. It is understood that either side may terminate the agreement at any time, although such action will only be taken after mutual consultation in order to avoid any inconvenience to either party. Should any revision or modification become necessary, a written amendment signed by both parties will be required.
- 17. We offer you referral on each student. The commission will be paid promptly for all your reported students within 7 working days after the compensation is released by the university (after the student is successfully placed in the respective university and pays the semester / year tuition fee as per the condition of that university). Bhaskar Pharmacy College have to raise an invoice for all their students in time.
- 18. The TDS & all other statutory taxes will be deducted while paying the commissions.
