## MEMORANDUM OF UNDERSTANDING

Free Non-Commercial MoU on academic collaboration

### 1. PURPOSE

This MoU establishes a collaborative partnership between DPMP and JBIET to co-develop and implement mental health and wellness initiative.

### 2. OBJECTIVES

- To enhance mental health awareness and emotional resilience.
- To build capacity among students, faculty, and staff.
- To offer certification programs and workshops in areas such as positive psychology, stress management, peer counselling, and mindfulness.

### **3. SCOPE OF COLLABORATION**

The Parties agree to the following areas of cooperation:

**a. curriculum design & delivery**

DPMP will design and propose training and certification content. Ownership of the original content remains with DPMP. JBES may request adaptations based on institutional needs; however, any adaptations, unless specifically agreed to be joint intellectual property, shall remain solely under the ownership of DPMP. A mutual written agreement will be required for any joint IP engagements.

**b. Workshops and certification**

Regular sessions on well-being, stress management, emotional intelligence, and mindfulness. certification to be offered by DPMP to eligible participants.

**c. Orientation**

DPMP shall provide orientation to faculty and coordinators designated by JBES.

**d. Feedback mechanism**

JBES will collect structured feedback and share it with DPMP for improvement.

**e. Branding and promotion**

DPMP shall acknowledge JBES in all collaborative events and publications.

**f. Research & wellness centre**

Parties may collaborate on joint research and explore setting up a mental health support centre within JBES institutions.

### **4. FEES AND PAYMENTS**

Program-specific fees will be mutually decided before implementation. Any financial arrangements shall be documented separately as annexures or definitive agreements.

### **5. INTELLECTUAL PROPERTY**

Each Party retains exclusive rights to its intellectual property. No transfer or licensing of IP is implied unless expressly agreed in writing.

### **6. VALIDITY AND TERMINATION**

This MoU shall be valid for three (3) year from the date of signing and will automatically renew for successive two-year period unless terminated by either party by providing 60 days' written notice prior to the end of the current term. Either party may terminate this MoU by giving 30 days' written notice. Obligations ongoing at the time of termination shall be fulfilled.

## 7. RELATIONSHIP BETWEEN THE PARTIES

The relationship is one of independent collaboration. This MoU does not create a partnership, joint venture, or agency. Neither Party may bind the other without prior written consent.

## 8. DISPUTE RESOLUTION

Disputes will be resolved amicably through mutual discussion. If unresolved, they shall be referred to arbitration as per the Arbitration and Conciliation Act, 1996. Jurisdiction: Hyderabad, Telangana, governed by Indian laws.




